

## Rules of the Crypto-Friday promotion

### 1. General provisions

1.1. The organiser of the **Crypto-Friday** promotion (hereinafter referred to as “the Promotion”) is StormGain Limited, having its registered office at the following address: Suite 15, 1<sup>st</sup> Floor Oliaji Trade Center, Francis Rachel Street, Victoria, Mahe, Seychells, (company registration number: 211202), hereinafter referred to interchangeably as “StormGain”, “the Company”, and “the Promotion Organiser”.

1.2. The promotion shall run from 00:00 (UTC+3) on 23/08/2019 (Promotion start date) until 23:59 (UTC+3) on 31/05/2019 (Promotion end date). This period shall be the validity period of the Promotion.

4.4. The Company's Customer Service department shall not review any claims or complaints associated with clients' participation in the Promotion.

4.5. In case of claims or complaints, the Promotion Organiser and Promotion Participants shall make every effort to resolve any disputes through negotiation.
